Seminar: Understanding Decision-Making in the EU: Principles, Procedures & Practice, 1-2 Dec 2011, Maastricht

The course explains how EU law is adopted. It first provides a framework for understanding EU decision-making, briefly explaining the treaty structure, the different kinds of competences which have been given to the EU. The different phases in the policy cycle are addressed in detail, using a combination of presentations, cases, simulation exercise to illustrate how the EC elaborates a proposal; how negotiations take place between the Member States, between the Council & the Parliament, how the new system of "delegated acts" & "implementing acts" actually operates. The participants will understand the principles/structures of the EU system, the basic competences, functioning of the EU institutions; the different stages in the legislative cycle; they will have an insight into how decisions are reached in practice.

This seminar focuses on the use of data, indicators, models and measurement tools for policy purposes. Over the years, public policies and programmes have advanced by knowledge-informed policy formation, evaluation/implementation.

Knowledge-informed policy

making requires the

combination of a variety of capacities: identifying what type of data/ information is needed, identifying the appropriate data sources, interpreting the relevance, validity/quality of these data, understanding how these data could contribute to improve consideration of policy options, policy formulation. In deciding on complex political actions, programmes, policy makers often prefer to make recourse to indicators, composite indicators and/or to various 'models'.

The seminar offers a discussion of the advantages/pitfalls of different approaches to evidence-based policy formulation, monitoring, evaluation. The issues are introduced by expert practitioners, academics, are followed by panel discussions on best practices, qualitative considerations (eg. transparency, acceptance, etc.).

Young talented individuals to meet again in Finland

If you were born between 1993-1996, you like math, science or technology, you can be interested in this youth camp. Millennium Youth Camp is free of charge to participants! The organisers take care of all costs, including flight tickets, travel, accommodation expenses. The application process for the 2012 Millennium Youth Camp has now begun.

A group of 30 talented young people will meet once again in Finland next June at the third Millennium Youth Camp. Online applications can be made starting from 19 October, and participants will be chosen using a two-phase selection process which will end in the middle of March 2012. This international camp offers like-minded young people who are interested in mathematics, science and technology a chance to spend a week doing project work together and also meet top scientists, the 2012 Millennium Technology Prize winner and people working in Finnish companies

and

organizations.

The week-long 2012 Millennium Youth Camp take place in the Helsinki Metropolitan Region, start on 9 June 2012. The project themes are climate change, renewable natural resources, energy, water, ICT, digitalisation, applied mathematics.

The two-phase application process: In the 1st phase, young people from all over the world who were born between 1993 and 1996 are eligible to apply for a place in the 2012 Millennium Youth Camp using the online application form. The names of the 100 applicants selected for the second phase of the application process will be

published on 1 February

2012, and they will be given a

period of four weeks to produce project plans. Some applicants will be interviewed by telephone in connection with their proposals. The 30 camp participants will be selected by a steering group consisting of representatives of Finnish higher educational institutions and Millennium Youth Camp partners.

The names of the successful applicants will be published on 15 March 2012.

Marie Curie Early Stage Researcher Computational Systems Biology, Vigo, Spain, Deadline 01.03.2012

Two Marie Curie Early Stage Researcher positions are available at IIM-CSIC, Vigo, Spain in the field of Computational Systems Biology. The ESR Positions in Computational Systems Biology has been classified as ESR9 and ESR10.

Fellow ESR9 will focus on mathematical model selection, optimal experimental design in systems biology. The main objective will be to use optimal experimental design methods to devise the necessary dynamic experiments for E. coli homeostasis modelling. Candidates should have a background in mathematical modelling, statistics, nonlinear analysis.

Fellow ESR10 will focus on advanced model identification, parameter estimation in systems biology. The main objective will be to devise new model calibration methods, to apply them to compute the parameters of E. coli homeostasis dynamic models from experimental (input-output) data.

Candidates should have a background in mathematical modelling, statistics and, ideally, software development, high performance scientific computing.
